

Meeting on Thursday, September 8<sup>th</sup> 2016 at 6:30pm

- I. Introduction – Welcome – Members present: Bert Buri, Lisa Buri, Jerry Fox, Laura Gentry, Paul Cagle, and LeeAnn Sulzner.
- II. Update from the Annual Community Yard Sale – Laura Gentry
  - A. There were many lots off of Hwy 64 that participated in the yard sale.
  - B. Less vendors but more homes participated. David Brown also rented out his lot for participants.
  - C. Financial Report by Paul Cagle: The Chamber of Commerce took a loss in the yard sale this year. To date \$547.00 has been paid to cover expenses. \$787.00 to 1674.00 has yet to be paid. One of the reasons for the higher amount was due to more advertising this year. Second reason, there were less vendors this year.
  - D. Suggestions for next year to bring in a revenue:
    1. Jerry's suggestion - Approach all the participants thanking them for their participation and give them a rack card and application to encourage them to become a member of the Chamber of Commerce.
    2. Jerry's suggestion - Have pointer/signs showing directions from the main highways to the Wartrace City Wide Yard Sale. Make sure that all flyers are branded with the Wartrace Chamber of Commerce.
    3. Laura's suggestion – Offer more Ads to buy from businesses and promote it earlier.
    4. Laura's suggestion – Attract Antique Car Clubs to show off their cars.
    5. LeeAnn's Suggestion – Jar for donations.
    6. Laura's suggestion – Chamber should have a booth to sell water and candy.
    7. LeeAnn's Suggestion – Schwan's fundraising, LeeAnn will research the possibility.
